Receive contributions on your account.

You'll receive the honeymoon of your dreams to the total value of contributions made, plus you can add any extra amount you wish. We will refund any money left in the account after the honeymoon has been paid for and all contributions have been made, leaving you with some spending money! Or you can leave the money in the account for future holidays.

The Honeymoon Gift Registry service is operated by Travel Counsellors Pty Ltd. To use this service the couple must agree to our terms and conditions as set out below:

- 1.0. The honeymoon Registry is a totally free service;
 - 1.1 The R250 deposit is purely to open the account and is by no means a charge and will be deducted from the cost of the Honeymoon when booked.
- 2.0 There is no minimum or maximum amount for contributions.
- 3.0 The Specified closing date for the contributions is the responsibility of the 'couple'. We recommend once week after the wedding.
- 4.0 All guests' cards must be clearly marked with both the name of the bride and groom, the file reference and the closing date for contributions.
- 5.0 The Freepost envelope must be clearly marked with the file reference
- 6.0 A deposit amount (determined by the Tour Operator) will be due at the time of booking, unless the reservation is made within 8 weeks of departure when payment will be due in full. If insufficient funds have been collected on the Honeymoon Account then it will be the responsibility of the lead name on the booking to ensure the holiday is paid in full on time.
- 7.0 The Balance Payment of the Honeymoon will be due 8 weeks before the departure date, NOT the date of the wedding. Should contributions in the Honeymoon Account fall short of the funds required, the lead name on the booking will be responsible for the payment of the remaining balance.
- 8.0 Once all funds are collected and the closing date has passed, the 'couple' will be notified of the total value of the contributions collected, when the following options will be available.
 - 8.1 Once all the holiday costs have been met, the remaining monies can be refunded by cheque or bank EFT.
 - 8.2 The total amount can be retained by Travel Counsellors for future travel arrangements, to be booked at a later date.
- 9.0 In the event that the 'couple' should decide not to book a honeymoon a refund charge will be imposed. The refund charge will be determined at the discretion of Travel Counsellors, but will be no great than R2, 500.
- 10.0 In the event of cancellation of the honeymoon, Tour Operator charges will apply, as per the Tour Operator booking conditions.
