## TERMS AND CONDITIONS

The Honeymoon Gift Registry service is operated by Travel Counsellors Ltd. To use this service the couple must agree to our terms and conditions as set out below:

- 1.0 There is a small fee to set-up your account which can simply be deducted from the cost of your honeymoon once booked.
- 2.0 There is no minimum or maximum charge for contributions on your account.
- 3.0 As part of this unique service you can purchase a beautiful Honeymoon Registry Pack. These are specially designed to send out with your invites to let your guests know how they can contribute towards your dream honeymoon.
- 4.0 All guest cards must be clearly marked with both names of the couple, the unique six digit file reference and the closing date for contributions.
- 5.0 The specified closing date for contributions is the responsibility of the couple. We recommend one week after the wedding.
- 6.0 A credit/debit card fee may be charged at the time of contribution.
- 7.0 A deposit amount (determined by the supplier/s you are booking through) will be due at the time of booking, unless the reservation is made after the balance due date then payment will be due in full. If insufficient funds have been collected on the Honeymoon Gift Registry account by the balance due date it will be the responsibility of the lead name on the booking to ensure the holiday is paid in full and on time.
- 8.0 Once all contributions have been collected and the closing date has passed, the couple will be notified of the total value collected on their account and then the following options will be available:
  - 8.1 Once all holiday costs have been met, the remaining monies can be refunded by cheque to the couple.
  - 8.2 The total amount can be retained by Travel Counsellors Ltd for future travel arrangements, to be booked at a later date at request of the couple
- 9.0 In the event that the couple should decide not to book a honeymoon through Travel Counsellors Ltd, a service fee will be imposed. The service fee will be determined and is at the discretion of your Travel Counsellor, but will be no greater than £150 (€180).
- 9.1 Once the service fee has been agreed, a refund of the remaining monies will be made to the couple. Travel Counsellors Ltd will not be responsible for returning any gift contributions to your guests.
10. In the event of a cancellation of the honeymoon, the standard supplier(s) cancellation charges will apply as per each suppliers booking terms and conditions.
